Through CRISTA Senior Living, 1,056 residents were served and \$108,307 was provided to assist low income residents to remain in their homes. The Nursing Center provided 30,864 days of care and CRISTA Shores Assisted Living provided 5,251 days of care for DSHS through the Washington state Medicaid program. Residents, family members, staff and other individuals volunteered 4,676 hours assisting other residents and tutoring elementary students. The Cristwood Nursing and Rehabilitation Center was the clinical setting for nursing or nursing assistant students from two local universities and one community college. Senior residents operate a missionary commission which supports faith based volunteers around the world. Approximately 485 community service and faith based meetings occurred in our facilities

4b (Code:) (Expenses \$ 23,547,412. including grants of \$ 10,404,035.) (Revenue \$ 12,081.) World Concern partners to transform the lives of poor and marginalized people through disaster response and sustainable community development. The love of Christ compels us to pursue reconciliation and equip those we serve, so that they may in turn share with others. In the past year, World Concern was active in 13 countries, supporting those who are left out of the main stream of humanitarian aid because of their location, ethnic background or societal power. The organization served 4,959,006 individuals through program services including livelihoods, child protection, disaster response and risk reduction, water and sanitation, non-clinical health and economic development. 4c (Code:) (Expenses \$ 17,417,313. including grants of \$ 1,363,989.) (Revenue \$ 16,454,797.) CRISTA Schools operates at two different locations. During the year, CRISTA Schools educated 1,127 K-12 students, 97 pre-K, and 45 high school students at Seattle Urban Academy. CRISTA Schools graduated 118 students and approximately 95% indicated that they planned to pursue higher education. Total financial assistance of \$1,363,989 was provided to 278 students while an additional \$1,133,000 was spent on the education of at-risk students. (At-risk students are required to pay 2% of costs for academic intensive care and student centered development). Approximately 105 students and 25 adults made missionary/education trips to 6 international and 2 domestic locations. Over 489 elementary students supported food projects for local relief agencies. Over 170 junior high students and 218 (4th, 5th, and 6th grade) elementary

At two camp sites, CRISTA Ministries served 25,525 campers through week

long camps, day camps and guest group programs. Approximately 135
