Somaliland Communities Resilience Enhancement (SCORE): The SCORE program addresses the severe water shortage of communities in Eastern Somaliland who suffer recurrent droughts. It builds on an ongoing twenty-five month OFDA-funded project. The lessons learned in the last grant show that sustained efforts in increasing the capacity for water harvesting need to be accompanied by a deeper understanding of the underlying causes of the water scarcity and the link between that and food insecurity. WCDO is rehabilitating water points such as shallow wells, roof catchments for institutions, and sub-surface tanks to increase their capacity for harvesting and storing water. Training water user committees and hygiene and sanitation committees to manage the water sources within the community and enhance the positive

Building Resilience in Eastern Chad (BREC): is a program targeting 30 agro-pastoralist communities, who have received no support since returning from displacement camps, through blanket distribution of staple rainy season seed and targeted vegetable and other dry season seeds. Farmers groups will be trained and provided with essential agricultural implements, which will jump start production, increase yields and increase acreage in an area long left fallow. The introduction of a System of Finger Millet Intensification (SFMI) pilot will provide data on the technique, which could have significant impact on Sahelian agricultural productions. To support economic growth and livelihood diversification, 30 new Rotating Saving and Credit Associations (ROSCA) groups will be selected with an average of five

Sustainable Agriculture and Livelihoods for Economic Recovery (SALER): is a program to improve access to food through increased agricultural production and post-harvest preservation. This includes teaching farmers how to improve crop and seed storage, how to grow vegetables for the purpose of marketing seeds and how to make farms productive year round. Fisherfolk also learned how to preserve their increased fish catch through smoking at the riverbank, reducing spoilage in the transport to markets. Additionally, this program increases access to business opportunities through capacity building. Trainings of previously established microcredit groups included literacy and numeracy, as well as business trainings aimed at enabling participants to develop their own small businesses for income generation.
